

SHELTER IN PLACE... IT'S THE NEW NORM!

On December 10, 2019, Hudson Milestones was mandated to go into Shelter in Place. As I called over the loud speaker and stated "THIS IS NOT A DRILL!", I knew I had no time to panic. If I looked or appeared nervous this would not work. There was no time to delay in locking down and securing the building for the safety of those we support and the staff who do it all!

As we secured the building and monitored the news, I saw the fear in the staff who had their children in the schools that were also in a true, not a drill, lockdown. I heard from the parents who wanted to pick up their loved ones. Yet, I had to say "we cannot open our doors. This is a safety matter for your family member and you, the guardian."

We live in different times. Times where hate, destruction and the loss of life are the new normal!!! People lost their lives on this day. They were all expected home for dinner. I write this article to urge you to think about how you will handle this the next time it happens. Because, sadly, the next time will come and we all must be prepared to REACT! Hudson Milestones plays an important role in safeguarding their clients and employees. We must prepare, plan, coordinate, and execute evacuation and shelter-in-place protective actions in case of threats or hazards impacting the workplace. Day Support Services Updates

The Day Habilitation Programs of Hudson Milestones continue to welcome new participants when openings become available and/or an opportunity for over-enrollment occurs. Both the Jersey City Day Habilitation (JCDH) and Bayonne Day Habilitation (BDH) Programs are currently filled to capacity. We continue to look forward to welcoming even more clients with the future opening of the Monmouth Day Habilitation Program in the next year. We are always willing to provide tours and meet & greets with prospective new participants. If for any reason we cannot immediately serve a prospective participant, we can add them to our waiting list.

The Fee-For-Service conversion is nearly complete in the day programs, and now more than 100 of the participants are part of the Supports Program. In the last six months, our staff have successfully changed over to electronic documentation of services rendered. DDD introduced a new form for providers to complete prior to annual ISP meetings and the tool has proven helpful in the meeting preparation.

The Hudson Milestones Respite Program has helped several clients over the past year to enjoy new activities while giving their caregivers a much-needed break. Our Respite clients have joined in After-Hour Program and Weekend Respite Program events and discovered interests they never even knew they had! If you or someone you know needs companionship and these helpful services – give us a call.

The Early Intervention Program continues to flourish, as our list of highly qualified practitioners grows! Exploring New Interests and Increasing Independence

Over the past year, our Respite clients have been working with staff to explore interests they never knew they had and increase their independence in the community. Client MS is an artist who enjoys drawing and painting but had always been uncomfortable in large groups. A few months ago, MS and her Respite provider decided to try something new to aid in her socialization and artistic skills. Staff Lolita convinces MS to give an After-Hour class a try and boy, was that a success! Turns out, MS not only enjoyed the arts & crafts projects she created but asked to come back the following semester. She did so this past fall and discovered she has a talent for singing Madonna and other 80's classics in the karaoke class. With staff's encouragement, a client who seemed to have few interests apart from listening to music, has really opened to new experiences and interests no one knew he had. Client MN can now be found out with Respite provider Keyonna either making his own karaoke memories, bowling, grabbing a snack at the diner or strolling around the mall. With staff support, client FR is learning to maintain safety in the community while traveling and following a public transportation schedule by using the Light Rail to travel to Newport Mall. Clients who live independently in their own homes are also receiving support from our In-Home Respite providers. They are active in the community with grocery shopping, furniture deliveries, maintaining the cleanliness of their home and preparing their own meals. The Respite Program not only provides families with time off as caretakers but also gives the clients we serve time to have fun. express themselves and build upon skills to increase their overall independence.

As continued practice, FY19 revenue regarding projections and conclusions were of sound prudent management. The results of FY19 were far beyond our goals and our successful margin improvement trend of the past years. This is due to the teamwork required by all departments and personnel remaining within their program budget and shopping around for better prices.

Our financial audit speaks for itself with regard to the Hudson Milestones financial management, integrity, internal controls, and policies.

We are pleased to have been part of the DSP Living Wage Coalition which plans to increase the DSP rate to \$15.00 an hour by 2024. However, it is imperative to note that on January 1, 2019, Hudson Milestones became the very first provider to offer full time DSPs \$15.00 an hour. We paved the path this has improved the quality of life not only for employees but for those we serve.

As we embark on a new year 2020, we will continue to implement improvement actions, helping to enhance our competitiveness with other providers and improve our financial performance sustainably.

RECIPE CORNER

Boneless Chicken Tenders

Come one come all, it's almost Super Bowl time and that means yummy food for the big game! Our Secaucus resident and JCDH participant, Sheliah, has a great and easy recipe to help you enjoy a Super Bowl Party or just a quiet evening at home!

INGREDIENTS:

- Paper towels
- Lemons
- Salt, black pepper, spices, herbs
- Baking pan
- 3 Bowls
- Tongs
- Cooking spray
- All purpose flour
- Eggs
- Breadcrumbs
- Boneless chicken tenders

PREPARATION:

- Pre-heat oven to 425 degrees
- Lay the chicken out on the paper towels, leaving a few inches in between each piece to absorb the moisture.
- Cut a lemon into wedges and squeeze onto each piece of chicken. Watch for seeds and remove if they land on chicken pieces.
- Sprinkle salt and pepper on each piece of chicken. Add spices or herbs such as sage and thyme. Turn each piece of chicken over and repeat the seasoning process on the other side.
- Coat a baking pan evenly with nonstick cooking spray. Spread out the seasoned chicken pieces on the pan, leaving space in between each piece.
- Put eggs, flour and breadcrumbs in the 3 separate bowls.
- Dip each piece of chicken into each bowl coating the chicken.
- Place back on the baking pan and bake in the oven at 350 degrees.
- Bake for 30 minutes or until golden brown.
